Dear Sirs,

Taking into account interest of your esteemed company towards establishment or continuation of business cooperation with LLC «RN-Bitumen» (group company of PJSC "OC "Rosneft") for oil & gas (chemical) products/hydrocarbons sales, we suggest that you send price quotations on the lot «**Delivery export production of bitumen refining, September 2020**», № 72/1-71 to purchase products under the offer selection procedure.

Product name/range, grade, quality, manufacturer, volume of sales, in line with the Attachment to the letter.

Contracting period – **September 2020** (by moving carry-overs volumes in October 2020, when shipping by rail).

The bitumen are offered on the following terms:

DAF border Russian Federation, FCA ex warehouse.

Conditions of delivery – 100% prepayment for bitumen resources. To make 100% advance payment for the products according to the offer within 3 banking days from the date of forwarding notification of the results of the tender via JSC "TEK-Torg" and the relevant Annex to the Purchaser via e-mail.

The allocation of the resource is based on the maximum possible amount of shipment based on the transport rate of loading vehicles 30 tons - when shipping by truck (FCA ex warehouse), and railway transport 65 tons - when shipping railway transport (except for packaged bitumen).

Mandatory conditions for your participation in the offer selection process are as follows:

1. Favorable results of pre-qualification;
2. The signed offer sent to LLC «RN-Bitumen» **not later than 12 a.m. Moscow time on August 25, 2020** including the following:
 - price quotations with one or a couple of suggested delivery bases;
 - product name, manufacturer;

- maximum quantity of products you are ready to purchase;
- delivery basis consistent with a price quotation;
- minimum bitumen order quantity filling: 30 tons shipped by truck (FCA ex warehouse) (transport rate of loading vehicles 30 tons except for industrial grades of bitumen in small packages) and 65 tons of shipping by rail (the transport rate of loading by railway 65 tons except for packed industrial, paving grades of bitumen, PMB - 55 tons shipped by open wagon).

3. The conclusion of a standard contract for the supply of petroleum products and Annexes to it, which are an integral part of the contract (the templates of the documents are given in the tender documentation).

4. The offer shall be presented in the following table format:

Offer **September 2020**, according to the Item 3 of the letter, shall be placed at ETP (Electronic Trading Platform) JSC "TEK-Torg" in the Section "Tender sale of hydrocarbons PJSC "OC "Rosneft" (<http://tender.tektorg.ru>), in accordance with the Regulations of the Section "Tender sale of hydrocarbons of JSC "OC "Rosneft" JSC "TEK-Torg". The offer shall include name and number of the pertinent lot.

The offers sent via different sources and/or addresses, as well as after the date specified in this letter, will not be accepted for review. Please, pay special attention to the offer format and content required for totaling and correct assessment of the offers.

Having reviewed your offer, we will inform you on the results as follows:

Before August 31, 2020, 6 p.m. (Moscow time) we will let you know about the review results. Herewith LLC «RN-Bitumen» reserves the right to send you a repeated invitation to make offers with improved cost or suggest updating of the submitted offer. In this case the repeated or updated offer shall be sent to LLC «RN-Bitumen» **not later than August 27, 2020, 6 p.m. (Moscow time)**.

Before August 31, 2020, 6 p.m. (Moscow time) you will be informed on the results of the repeated or updated offer review. At the conclusion of the

Contract and/or additions to the current Contract on the conditions of the tender offer, the tender winner is required.

If the bid winner refuses to execute a contract and Annexes to it, which are an integral part of the contract based on the accepted offer in terms of any of the shipments agreed, LLC «RN-Bitumen» will have a right to sell this amount to the third parties, charging the bid winner for all possible loss.

Please note that from January 1, 2020, Rosneft Oil Company PJSC will reinforce the penalty system as part of enhancing the performance discipline regarding the parties' obligations under the Contract. Under the terms of the Contract, you will be charged monetary penalty to compensate for the Company's losses in the event of violation of the delivery obligations. Furthermore, according to the internal procedures, if you are in breach of the Contract, the Company reserves the right to suspend or deprive your company of pre-qualifications for participation in tendering procedures of Rosneft Oil Company PJSC so as to be irrevocable.

In the case of non-execution of the conditions of the Agreement to the Contract, registered by the results accepted the offer, including in case of non-provision of vehicles under self, violation of the obligation to pay, non-provision application for shipment ready to transfer the goods in full (volumes) and in breach of other obligations, necessary for the enforcement of the obligation to deliver the goods (tar, bitumen) by provider, LLC «RN-Bitumen» has the right to terminate the supply agreement and apply penalties under the terms of the Contract of supply of petroleum products.

We would like to draw your attention to the fact that if the bid winner changes delivery terms in the future, including netback parity preservation, the seller (supplier) will retain the right not to fulfill such a request.

Concerning additional conditions and rules of this tender (be it delivery basis, transportation facilities, pricing period, delivery period or any other substantial tender conditions stated in this Tender invitation). Please be aware that in case there is no reference or comments on these conditions of any kind, LLC «RN-Bitumen» reserve the right to consider your proposal "by default" accepting all such conditions and evaluate your bid taking these conditions and rules. Once again we ask you to pay additional attention to the information you provide for tender.

Additionally informing you about main requirements, concerning transportation vehicles, for bitumen products transportation services by automobile transport (self-transportation from the plant):

- Transport vehicles have to be of approved type and in accordance with the laws and requirements of the Russian Federation in road safety, including the Rules of dangerous cargo transportation of automobile transport, ratified by the order of the Ministry of Transportation of the Russian Federation of

08.08.1995 №73, DOPOG, that is confirmed by presenting the active certificate of DOPOG for the transportation vehicle;

- Drivers of the Vehicles have to have the original copy of DOPOG certificate, confirming that the drivers passed preparation courses and passed the exams of special training about dangerous cargo transportation process in accordance to the DOPOG requirements;
- For each transportation vehicle, that is involved in transportation of the Company's products (including tow trucks and trailers) has to have original certificates of approval to commence dangerous cargo transportation.
