The offers sent by other means of communication and/or to other addresses, as well as after the deadline mentioned herein shall not be considered. Moreover, please pay special attention to the offer format and contents which should allow quick summing up and unbiased assessment of the offers.

3. You shall be informed of the results of your offer consideration as follows:

By 6:00 p.m. Moscow time November 25, 2020 the notice of the results of your offer consideration shall be sent to you. However, RN-Lubricants, LLC retains the right to send you a repeated invitation to provide an offer with improved prices or a proposal to clarify the parameters of your offer. In this case the repeated offer or the specification to the offer should be sent to RN-Lubricants, LLC not later than 6:00 p.m. Moscow time November 23, 2020.

The results of consideration of the repeated offer or the specification to the offer shall be communicated to you by 6:00 p.m. Moscow time November 25, 2020. The successful bidder must comply with the conditions of the offer.

- 4. The offer shall be deemed to have been accepted, if both following conditions are met:
- a) A written notice of the offer acceptance is sent to your company by RN-Lubricants, LLC by **6:00 p.m. Moscow time November 25, 2020**. The said notice shall be signed by an authorized person of RN-Lubricants, LLC.
- b) The contract (if not signed before) and/or Annex in accordance with the contract for the supply of a certain product quantity under the accepted offer specifying the price set in the accepted offer is sent to your company by RN-Lubricants, LLC after the notice mentioned in clause 4.a).

The actions mentioned in clause 4 shall be deemed a full and irrevocable acceptance of the offer as to the quantity of the product specified in the Annexes including the option of Supplier within +/-10% of product quantity specified in the Annexes and imply conclusion of a deal for supply of the product quantity specified in the Annex between RN-Lubricants, LLC and the person who had made the offer on the terms and conditions of the offer and the contract with RN-Lubricants, LLC.

- •suspend the results of the positive assessment of compliance with the eligibility requirements,
 - •sell the respective product quantity to a third party,
- •charge penalty and compensate for losses in accordance with the contract and applicable Russian laws.
